

Participant Permissions, Rules, & Waiver for Religious Exploration Activities At First Parish Milton

Participant or Legal Guardian Permission: By signing this document or otherwise indicating consent (via an online form etc.), I indicate that I am either the adult Participant or the legal guardian of the Participant(s), if Participant(s) is/are a minor. I choose to or allow the Participant(s) to participate in the event/activities of the church, including transportation related to the events/activities, if needed.

RE Kids & Youth Rules:

As part of participation, I understand that Participants are expected to follow a few rules for everyone's well-being:

- 1) Kids/Youth should check-in at the beginning of an event and check-out before leaving an event.
- 2) If transportation plans of picking up a kid/youth change while attending an event, staff needs to receive a text, call, or email stating they have approved the change.
- 3) Kids/Youth should always follow the directions/rules of the staff/chaperones/venue. If kids/youth violate any directions, rules, or laws, they may be sent home at the discretion of the staff and the expense of their parent/guardian.
- 4) All youth and adults volunteers agree to abide by the church's Safe Environment Policy. If I have not already been provided a copy of this policy, I understand I can request a copy at any time from staff.

Transportation Policy & Permissions: I understand that some events require transportation and allow Participant(s) to use transportation provided. Should the program run out of space on church provided vehicles it may be necessary for Participant(s) to ride in the personal vehicle of other participants, staff, or volunteers. I agree to this policy unless otherwise stated in writing to the Director prior to the event.

Medical Policy & Permissions: Unless otherwise stated in writing to the Director prior to the event, I grant designated staff & chaperones permission to:

- 1) administer first aid to Participant(s) for minor medical issues
- 2) administer specified medications or medical assistance detailed in writing
- 3) In the event of an accident or illness, act as agents for me to consent to treatment deemed advisable by professional medical personnel. If the Participant(s) needs medical treatment as a result of participation, I agree to be responsible for costs incurred as a result of such treatment.

Photo Policy & Permissions: I understand that the church sometimes takes photos, audio and videos of Participant(s) to use on our website, social media, & other media outlets; and I agree to this policy unless otherwise stated in writing to the Director.

Waiver & Release:

By choosing to participate—or allowing my child(ren) to participate—I waive the right to bring any legal action against the church's employees, officers, volunteers, and agents. I release them from all liability for any claims that may arise from participation in this activity. I understand that I, if a legal guardian, am responsible for the actions and obligations of any minor Participant(s). I acknowledge that participation involves certain risks, both known and unknown, and I voluntarily assume all such risks. I agree to hold the church harmless from any and all claims, losses, damage to personal property, liabilities, and costs (including attorney's fees) resulting from participation.
